- Fires after blast, storm, flood, earthquakes, impact and collision.
- Different scales: construction project, aggregate, district and regional.
- Approaches: vulnerability, management, medical, mitigation, robustness-based design.
- Objectives: infrastructure and buildings.

#### Smoke in fire in infrastructure and buildings

# 6. Projects under WP7 Educational dimension

Possibilities for funding of educational initiatives had also been considered. Dubravka Bjegovic proposed that members of TU0904 should prepare an EU educational project related to fire safety. An application to Erasmus for All will be drafted, and the interested Universities will create a Consortium. The Consortium will be finalized at the Aveiro 2013 meeting.

### 7. Progress and planning of WP4 - Benchmarks for structural fire engineering

Leslaw Kwasniewski presented the current situation. The published deliverable is anticipated to contain three chapters:

Experts coming to the Aveiro meeting are asked to deliver and present the drafts of their benchmark studies at the meeting.

The Monograph will be prepared during the month after the Aveiro meeting. Kamila Horová will coordinate the activity. Leslaw Kwasniewski will manage the responsible authors from each team.

#### 8. WP6 - Thought for Eurocodes upgrade

This publication is expected to be prepared on the basis of two contributions from each member. Two chapters are expected:

- A. Procedures for application of fire design under national rules, cooperation between the authorities of European countries, information about individual countries. A questionnaire will be devised and managed by Jyri Outinen.
- B. Proposals for improvement, based on local/European projects. Introduction of the latest research into standards; Paulo Vila Real will lead this part.

External experts (for example chairs of Eurocode evolution committees) will be invited to the Aveiro/Krakow meetings.

The contributions to both chapters should initially be developed by experts in time for the Aveiro meeting.
